That on or about March 13, 2010, in Dakota County, Minnesota, KRISTI ANNE HIDALGO did intentionally inflict or attempt to inflict bodily harm upon a family or household member.

STATEMENT OF PROBABLE CAUSE

The Complainant states that the following facts establish probable cause:

Your Complainant is a police officer with the Apple Valley Police Department. In that capacity I have reviewed the police reports and believe the following to be true.

On March 13, 2010, at approximately 8:40 a.m., an officer with the Apple Valley police department was dispatched to the emergency room at Regions Hospital in reference to a possible assault victim. Upon arrival the officer entered the exam of a male victim, J.R., who was lying on the exam table with a bandage wrapped around his right leg. Seated in a chair nearby was an individual, Kristi Anne Hidalgo, DOB: 1-15-65, identified as the victim’s wife. When the officer approached the victim and asked “Hey what happened?” Hidalgo stated, “We were arguing at our apartment and I went in the kitchen and got a knife and accidentally stabbed him in the leg!” The officer then confirmed that the victim and Hidalgo were husband and wife. The

two of them have been married for approximately nine or ten years. Hidalgo was placed under arrest and agreed to give a further statement to officers. Hidalgo indicated that the victim arrived home late that morning, around 12:30. Hidalgo indicated that she and the victim argued about the situation. Hidalgo reported that at some point during the argument she went into the kitchen and grabbed the knife. Hidalgo indicated that the two of them continued to argue and that she didn't mean to, but she stabbed the victim in the leg. Hidalgo indicated she was only trying to scare him. Hidalgo did not know where the knife was at this time. Hidalgo later reported that she went to bed and was awakened by the victim, as the wound was still bleeding and the victim needed to be taken to the hospital. When police spoke with the victim he reported that the stabbing took place while the victim was sitting on the floor in the living room leaning up against the couch. The wound did require three stitches. Officers then executed a search warrant of the residence where they discovered a large amount of blood droplets on the floor of the residence. There was also blood on a quilt in the living room and bloody rags.

***NOTICE: You must appear for every court hearing on this charge. A failure to appear for court on this charge is a criminal offense and may be punished as provided in Minn. Stat. §609.49.***

Complainant requests that Defendant, KRISTI ANNE HIDALGO, subject to bail or conditions of release, be:

- (1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court, or
- (2) detained, if already in custody, pending further proceedings, and that said Defendant otherwise be dealt with according to law.
